**INSTRUCTIONS FOR FILLING OUT THE FORM  
of practical training certificate**

Applicant's data – TO BE FILLED IN BY THE APPLICANT

1. The applicant fills in their surname, first name and personal identification number (PID);

**Data on educational/study programme institution – TO BE FILLED IN BY THE EDUCATIONAL INSTITUTION**

2. The authorized person of the provider of the educational/study programme shall enter the name of the educational institution/study programme provider and the address of the training location. The address of the school/faculty within the EI/HEI shall be in the following format: title, town, street, street number with any addition, postal code and post office name. In order to decide on the applicant's right to purchase a subsidized pass it is necessary to provide the exact address of the school/faculty carrying out the education/study programme (the address of the school/faculty is not necessarily the same as that of EI or HEI).
3. The authorized person of the provider of the educational/study programme shall enter the school/academic year of enrolment by entering the year of enrolment in the current school/academic year; e.g. for the academic year 2016/2017, 2016 shall be entered.
4. The authorized person of the provider of the educational/study programme shall enter the year of study in which the applicant is enrolled (e.g., 1st, 2nd, 3rd, etc.).

Data on practical training – TO BE FILLED IN BY THE EDUCATIONAL/STUDY INSTITUTION:

5. The authorized person of the provider of the educational/study programme shall enter the name and address of the organisation where practical training as part of the education process will be carried out.
6. The authorized person of the provider of the educational/study programme shall enter the period of practical training (from... to...). The applicant shall enter the number of days of practical training per week (e.g.: once, twice, etc.).
7. The authorized person of the provider of the educational/study programme shall indicate the date, sign and certify the form with the stamp.
